**ESSENTIAL FUNCTIONS OF THE POSITION** (For purposes of 42 USC 12101)

1. Plows and salts roads and various Township grounds (i.e., Township Hall, fire station, garage, etc.); ensures snow plows are safe for operation; assists in maintaining snow plow markers; cleans salt spills and repairs/replaces damaged mailboxes; paves and grinds Township roads; ensures roads are maintained properly (i.e., patches potholes, etc.).
2. Mows various Township grounds (i.e., Township Hall, fire station, new lots, berms, etc.); performs general maintenance and upkeep of Township property (i.e., replaces street signs, stocks restrooms, cleans garage, etc.); maintains cemetery (i.e., trims trees, sells lots, digs graves); installs and removes Christmas decorations; assists with Christmas tree recycling program.
3. Cleans and repairs catch basins; sweeps street debris; removes illegally dumped items and roadkill from roadways; repairs and installs ditches throughout the Township; runs sewer jet through plugged pipes; helps residents with various drainage issues; installs rip rap to prevent erosion.
4. Utilizes heavy machinery to haul various materials (i.e., scrap steel, dirt to fill low areas and the cemetery, etc.); cuts up and hauls away fallen trees; uses wood chipper to clear brush and limbs.
5. Meets all job safety requirements and all applicable OSHA safety standards that pertain to essential functions.
6. Demonstrates regular and predictable attendance.
7. Maintains required licensure and certification.
