Meeting held on April 26, 2022 at 5:34 P.M.

Canfield Township Trustees held a special meeting to discuss the property at 4816 Messerly Road in the Canfield Township Hall on Tuesday, April 26, at 5:34pm. This was noticed in *The Vindicator*, an edition of the *Tribune Chronicle* on April 26, 2022 as required by the Ohio Sunshine Law.

Cody Elyko, owner of the property at 4816 Messerly Road, was present virtually.

Mr. Elyko stated that the updates to the structure located on the named property were as follows: 1) pumping of the basement has been slow and steady, approximately eight hours/week, the County cleaned the ditch as requested, and the follow-up inspection was completed, 2) due to the backorder of shingles, the roof still has not been repaired. Mr. Elyko added that he had contracted with another roofer to do the wood and rolled cloth by May 17th.

After discussion between Trustees and property owner, the Trustees decided to give Mr. Elyko a deadline of June 1, 2022 for roof repair. It was also decided that no more extensions would be given after that date. If, in the event, the roof was not completed by the deadline, then abatement would proceed.
