PUBLIC PRESENTATION

The Board recognized Heidi Ferg of S. Raccoon Road, who has concerns about the Flock cameras the Mahoning County Sheriff's Department is asking the Township to consider installing.

The Board recognized Bruce Neff of the Canfield Heritage Foundation that runs the site known as Loghurst which is owned by the Western Reserve Historical Society. The Canfield Heritage foundation is looking at possible installing an athletic field for Ultimate Frisbee and other sports along with a dog park on the property.

MINUTES: Chairman Governor moved to approve the special meeting minutes of February 27; the regular meeting minutes of February 28; and the budget meeting minutes of March 6, 2023. These minutes with suggested changes were incorporated and accepted.

ADMINISTRATOR/ROAD SUPERINTENDENT REPORT: Mr. Rogers asked the Board for thoughts on economic development projects which could be submitted for the State Capital Budget.

Cornersburg Cemetery Update: Mr. Governor stated the Board is waiting to hear back from the Mahoning County Prosecutors office on whether the *Dean Hill Cemetery* Rules and Regulations automatically apply to the *Cornersburg Cemetery* since the Township owns both cemeteries. Mr. Rogers stated routine maintenance is continuing.

Township Park: Mr. Rogers stated the OSB board was installed at the Park garage; waiting on the invoice from the contractor.

The Board asked Mr. Rogers to get quotes for fall protection for the playground at the Township Park.

The Fertilization contract reads three applications for common areas plus two applications of all athletic fields for a total not to exceed \$5,235.00. Township's Community Park Maintenance Contract

Mr. Paloski moved to accept the best low qualified bid for the Township Community Park lawn mowing maintenance from Easton Lawn Service for the area included in the bid package noted as Area #1 located on the South side of Herbert Road at a cost of \$199.00 per cut. Area #130 cuts at \$199.00 Total of Contract - not to exceed \$5,970.00. Mr. Governor seconded the motion. Discussion: The funds for this work will come from the General Fund – Contracted Park Services. Roll Call: Mr. Paloski, yes; Mr. Governor, abstain; Mrs. Cartwright, yes. Motion carried 2 to 0.

MOTION 2023-39 2023 Stormwater Conference

Mrs. Cartwright moved to approve the Administrator/Road Superintendent Keith Rogers and Zoning Inspector Traci DeCapua to attend the 2023 Stormwater Conference in Sandusky, Ohio from Wednesday, May 10 thru Friday, May 12 for the purpose of continuing education with the Township paying for the conference and all related expenses per the Township's travel policy. MOTION 2023-40 Purchase of 1-Ton Truck

Mr. Governor moved to approve the purchase of a 2023 Ford F-550 stock number X5H cab and chassis along with a 2023 Stainless Steel Galion Dump Body and Western Pro Plus Angling 9' Plow and complete upfit kit as quoted by Cross Truck Equipment Co. Inc. at a total cost not to exceed \$87,500 which is at state purchase price from Tri State Ford of East Liverpool, Ohio. The funds will come from line #1000-760-790-0000 Other - Capital Outlay. Mr. Paloski seconded the motion. Discussion: There was a letter of intent motion that was passed on December 13, 2022 to hold the position for the production of the truck Cab and Chassis not to exceed \$75,000 at state purchase price. There would be one Purchase order and payment to Tri State Ford of East Liverpool, Ohio. This motion includes the trade-in of the Township's 2019 Ford F-250 with plow for \$36,500 which is more than the Township has invested in the truck. Mrs. Cartwright stated she was voting based upon the recommendation of the Township Administrator and Assistant Public Works Maintenance Foreman, however she doesn't expect a request for more trucks in the near future. Mr. Paloski stated Major Jeff Allen, Mahoning County Sheriff's Department would be available April 11 to give the quarterly patrol report; and the YSU student volunteers would like more information about the Fiscal Office records retention and would like to set a date for this project.
